2.1	It was a pleasure to have new faces, introductions were made, and	
	apologies were sent by those who could not attend.	
	The following points were discussed:	
	- July 2025 newsletter was reviewed.	
	- New staffing members discussed.	
	- The May 2025 insight into appointment data was shared, the group	
	discussed the reduction in the Did Not Attend appointments.	
	- I was delighted to inform the group that the practice had won an NHS	
	England bid to build two additional clinical rooms, to be completed by	
	March 2026.	
	- Online Consultation System – as a group we discussed the NHS	
	England's plan which is a contractual update for all GP Surgeries, the	
	wording in the contract states:	
	We want patients to contact their practice, by phone, online or by walking in,	
	and for people to have an equitable experience across these access	
	modes. This will be a key intervention in the government's ambition to end	
	the 8am scramble. From 1 October 2025 practices will be required to keep	
	their online consultation tool open for the duration of core hours for non-	
	urgent appointment requests, medication queries and admin requests. This	
	will be subject to necessary safeguards in place to avoid urgent clinical	
	requests being erroneously submitted online. Guidance will be displayed on	
	practice websites and reflected in the wording of the patient charter (see	
	below).	
	By no later than 1 October 2025, practices will be also required to ensure	
	the functionality in GP Connect is enabled which:	
	<ul> <li>allows read only access to patients' care records. This will apply to</li> </ul>	
	other NHS commissioned providers for direct patient care and also to	
	providers of private healthcare where the private provider obtains	
	explicit permission from the patient to access their NHS GP care	
	record and they are providing direct care to the patient.	
	allows Community Pharmacy registered professionals to send	
	consultation summaries into the GP practice workflow – which will	
	reduce administrative burden for general practice teams.
